



International study programmes at the University of Economics, Prague

The University of Economics, Prague (VŠE) offers study programmes taught in foreign languages at every level of university education – bachelor, master, doctoral and MBA. The programs' education languages include English, French and Russian.

For the 2015 / 2016 academic year, the University of Economics, Prague offers 3 bachelor's programmes in English and 1 bachelor programme in Russian. The students can also send an application to one of the 6 Master's programmes in English and 2 MBA programmes.

Bachelor of International Business is a three-year (six-semester) full-time bachelor's degree program taught in English at the Faculty of International Relations. Applicants complete an entrance exam in long-distance form. The procedure consists of an essay on a given economic topic and a motivation letter, both of which need to be written in English. The deadline for applications for the 2015/2016 academic year is April 30, 2015.

Bachelor of Corporate finance and Management is a three-year bachelor's degree program taught in English or in Russian offered by the Faculty of Business Administration. Applicants have to pass entrance exams in (high schools) mathematics and English language which held on June 25. The deadline for applications for the 2015/2016 academic year is June 10, 2015.

Bachelor of Economics is a three-year full-time bachelor's degree program taught in English at the Faculty of Economics. Applicants complete an entrance exam in long-distance form. The procedure consists of an Essay on a given economic topic, and a Motivation Letter. Both of which need to be written in English. Both of them have to be sent until the Deadline – April 30th, 2015.

CEMS Master in International Management is a full-time two-year academic training programme taught in English. An indispensable part of the studies is a semester spent abroad at a CEMS Partner University. The admission procedure consists of three rounds. The deadline for applications for the 2015/2016 academic year is February 27, 2015.

International Business – Central European Business Realities is a two-year (four semesters) full-time Master's Program taught in English. The admission exam (long-distance) consists of a written essay in English, a motivation letter and study prerequisites (Bachelor degree, English certificate corresponding to the "B2" level of the [CEFR](#) ...). The deadline for applications for the 2015/2016 academic year is April 30, 2015.

International and Diplomatic Studies is a two-year full-time Master's Program taught in English. The admission exam (long-distance) consists of a written essay in English and study prerequisites (CV, transcript, reference). The deadline for applications for the 2015/2016 academic year is April 30, 2015.

Economics of Globalisation and European Integration is an English-language international studies programme. The programme is organized by a consortium



of nine partner universities. The entrance exam in English consists of the oral part, the appraisal of study results and other study prerequisites. The deadline for applications for the 2015/2016 academic year is April 30, 2015.

For the 2015/2016 academic year there are two new master's programmes which are offered by the Faculty of Informatics and statistic: **Information Systems Management** and **Quantitative Economic Analysis**. The deadline for applications is April 30, 2015.

The tuition fee for the bachelor's programmes taught in English is EUR 3 600 / academic year. The master degree study programs are provided in cooperation with partner universities abroad. Therefore, the tuition fee differs according to the program characteristics in range from EUR 1,800 to EUR 3,600 /academic year. **Doctoral study programs** in English are offered by all VŠE faculties and the tuition fee is EUR 5,000/ academic year.

MBA program education is provided only partially in foreign languages. The Faculty of Business Administration offers an MBA program accredited by FIBAA with several education study blocks which are taught in English. The French-Czech Institute of Management (IFTG) offers an MBA program with a French state Master's diploma accredited by the Ministry of National Education of France. One half of the education is provide in French.

The University of Economics, Prague (Vysoká škola ekonomická v Praze) is the leading university in the field of management and economics in the Czech Republic. The University of Economics, Prague is composed of more than 20,000 students and has six faculties – five in Prague and one in Jindřichův Hradec in South Bohemia. These include: the Faculty of Finance and Accounting, the Faculty of International Relations, the Faculty of Business Administration, the Faculty of Statistics and Informatics and the Faculty of Economics and Public Administration. The faculty based in Jindřichův Hradec is specialized in management. Graduates of the University of Economics, Prague occupy responsible positions in the private as well as in the public sector. Most of them are employed in the sectors of industry and services, trade, marketing, banking, public administration, accounting, audit, tourism and the field of information technology. Many significant Czech and foreign economists have obtained the University's honoris causa title; for example, the Nobel Prize winner Prof. Robert A. Mundell, Prof. Milton Friedman and Prof. Gary S.
